<p>DURING AN INSPECTION OF YOUR FIRM WE OBSERVED: OBSERVATION 1</p> <p>Clothing of personnel engaged in the manufacturing of drug products is not appropriate for the duties they perform.</p> <p>Specifically, on 04/16/2018 we observed a sterile pharmacy technician in the ISO 7 area with their neck skin clearly visible due to improper gowning. The technician went into the ISO 8 area to fix the gowning, and returned to the ISO 7 after spraying gloved hands with (b) (4) but without replacing gloves. Additionally, the safety goggles used by all sterile technicians and the supervising pharmacist in the ISO 7 compounding areas, and working in the ISO 5 laminar flow hoods, have (b) (4) (b) (4) that may allow contamination of the aseptic compounding area.</p>
