<p>DURING AN INSPECTION OF YOUR FIRM WE OBSERVED: OBSERVATION 1</p> <p>You produced beta-lactam drugs without providing adequate cleaning of work surfaces to prevent cross-contamination.</p> <p>Specifically, you aseptically processed beta-lactam antibiotics in the ISO 5 (b) (4) in the past three months. Your cleaning procedure does not identify the use of appropriate cleaning agents to reduce the risk of cross-contamination for these products.</p>		
<p>OBSERVATION 2</p> <p>Materials or supplies were not disinfected prior to entering the aseptic processing areas.</p> <p>Specifically, on August 27, 2018, we observed the operator wipe supplies in the ISO 8 area with (b) (4) and continue to transfer them into the ISO 5 aseptic processing area with no additional wipe down on the supplies. These supplies were used in the aseptic processing of daptomycin 425 mg in 100 mL of 0.9% NaCl, prescription (b) (6)</p>		
<p>OBSERVATION 3</p> <p>Media fills were not performed that closely simulate aseptic production operations incorporating, as appropriate, worst-case activities and conditions that provide a challenge to aseptic operations.</p> <p>Specifically, your firm's practice of media fills does not include using a microbiological growth medium in place of the product. Your firm injects (b) (4).</p>
