Non-pharmaceutical grade components are used in the formulation of non-sterile drug products.

Specifically, your firm uses (b) (4) that is (b) (4) through the (b) (4) (b) (4) system for the production of Sodium Bicarbonate and Omeprazole. However, your firm did not provide any documentation supporting the (b) (4) used in production is (b) (4). Your firm does not conduct any microbial testing on any drug products that use this system. Hazardous drugs were produced without providing adequate containment, segregation, and/or cleaning of work surfaces, utensils, and/or personnel to prevent cross-contamination.
